RELEASE OF SECURITY INTEREST
IN TRADEMARKS

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks, and retransfers and reassigns to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Agent, all of Agent's right, title and interest, if any, in and to the Released Marks and all goodwill associated therewith.

Agent hereby reserves all of its rights and remedies under the Agreement with respect to any trademarks and trademark applications (other than the Released Marks), and all goodwill associated therewith, in which a security interest was granted under the Agreement and was not heretofore released or discharged by Agent.
