Whereas, "Aqua-Life" wishes to accept such assignment;

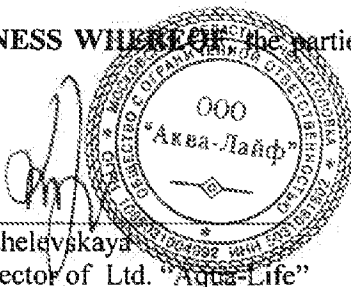
