ASSIGNMENT OF U.S. TRADEMARKS

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) or the equivalent thereof, and other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby sell, assign and transfer unto said ASSIGNEE, and ASSIGNEE hereby accepts, ASSIGNOR's entire right, title and interest in the Marks, together with the goodwill of the business symbolized by the Marks; to the extent any pending applications for registration of a Mark have been filed on the basis of ASSIGNOR's "intent-to-use" such Marks, that portion of ASSIGNOR's business to which such Mark pertains (which is ongoing and existing); and any causes of action for any previously occurring infringement of the Marks except to the extent relating to an Excluded Liability (as defined in the Asset Purchase Agreement between the parties, among others, dated as of July 23, 2010).

ASSIGNOR will execute further commercially reasonable papers and will take other commercially reasonable action if necessary and proper to vest full title in and to the Marks in ASSIGNEE.


