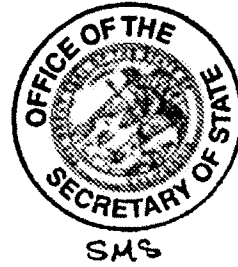

CERTIFICATE OF MERGER
OF
BERKELEY PROCESS CONTROL, INC.
INTO
MOOG INC.

Under Section 905 of the
Business Corporation Law of the State of New York

The undersigned, John B. Drenning, being the Secretary of Moog Inc., a corporation duly organized and existing under the laws of the State of New York, and the surviving corporation of the proposed merger, does hereby certify as follows:

1. (a) The board of directors of Moog Inc., the parent corporation, duly adopted an Agreement and Plan of Merger to merge Berkeley Process Control, Inc. with and into Moog Inc.

(b) The name of the corporation to be merged is Berkeley Process Control, Inc., hereinafter referred to as ("BPC").

(c) The name of the surviving corporation is Moog Inc., a New York corporation, hereinafter referred to as ("Moog"). Moog was originally incorporated under the name Moog Valve Co. Inc.

2. (a) The designation and number of outstanding shares of each class of BPC, the corporation to be merged, is Thirteen Million One Hundred Fifty-Two Thousand One Hundred Thirty Six (13,152,136) common shares of stock with a par value of \$.001 per share, all of which are entitled to vote and all of which are owned by Moog, the surviving corporation.

(b) The number of outstanding shares of BPC is not subject to change prior to the effective date of the merger.

3. The terms and conditions of the proposed merger are as follows: Upon the effective date of the merger, the outstanding common shares of stock of BPC shall be cancelled and shall cease to be outstanding, without any consideration being paid to the sole shareholder in respect thereof.

4. The effective date of the merger of BPC into Moog shall be April 1, 2009 (the "Effective Date").

5. (a) The date when the Certificate of Incorporation of Moog was filed by the Department of State of the State of New York is August 1, 1951.


(b) The date when the Articles of Incorporation of BPC were filed by the Secretary of State of the State of California is June 15, 1981. No application for authority to transact business in the State of New York has been filed on behalf of BPC, and BPC will not do business in the State of New York until such application has been filed.

6. The merger is permitted by the laws of the State of California, the State of incorporation of BPC, and is in compliance therewith.
