**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, effective as of August 31, 2010, is made by Bank of America, N.A., as Collateral Agent (as defined below), in favor of Harrah's License Company, LLC ("**Company**") as follows:

**W I T N E S S E T H**

WHEREAS, Harrah's Operating Company, Inc. (and each Subsidiary Party signatory thereto, including the Company) (each, a "**Pledgor**"), entered into that certain Trademark Collateral Agreement, dated January 28, 2008 (as may be supplemented from time to time) ("**Security Agreement**"), in favor of Bank of America, N.A., as collateral agent (the "**Collateral Agent**"), pursuant to that certain Credit Agreement dated as of January 28, 2008 (as amended, restated, supplemented, waived or otherwise modified from time to time (including by that certain Amendment and Waiver to Credit Agreement dated as of June 3, 2009 (the "**Credit Agreement**")) and that certain Amended and Restated Collateral Agreement dated and effective as of January 28, 2008 and amended and restated effective as of June 10, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Collateral Agreement**") in favor of the Collateral Agent to which each Pledgor is a party;

WHEREAS, pursuant to the Credit Agreement, the Pledgors granted the Collateral Agent a security interest in and to various trademark registrations and applications for registration owned by each respective Pledgor (the "**Trademark Collateral**"), including the Company's grant of a security interest in all of its right, title and interest in the trademark registrations and trademark applications set forth on Schedule 1 attached hereto (the "**Assigned Trademarks**");

WHEREAS, Company has disposed of the Assigned Trademarks to a third party and has requested that Collateral Agent release its security interest in the Assigned Trademarks;


WHEREAS, the Security Agreement shall continue to remain in full force and effect with respect to the remainder of the Trademark Collateral but excluding the Assigned Trademarks;

NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty and at Company's sole cost and expense, hereby RELEASES all of its right, title and interest in and to each of the Assigned Trademarks and all of the goodwill associated with the Assigned Trademarks.
