

Pursuant to Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA"), Mold-Rite Plastics, LLC, a Delaware limited liability company (the "Company"), in connection with the merger (the "Merger") of Mold-Rite Plastics, Inc., a New York corporation ("Mold-Rite"), with and into the Company, hereby certifies as follows:

FIRST: The respective names and states of formation or incorporation of the constituent companies to the Merger are as follows:

FIFTH: The Merger shall become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

SIXTH: An executed copy of the Merger Agreement is on file at the office of the Surviving Company located at 1 Plant Street, Plattsburgh, New York 12901. A copy of the Merger Agreement will be furnished by the Surviving Company, on request and without cost, to any member of the Surviving Company or any stockholder of Mold-Rite.
