RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is granted as of September 7, 2010, by Bank of America, N.A., as successor by merger to LaSalle National Bank, a Banking Corporation, in its capacity as Agent for the Secured Parties under (and as defined in) the Trademark Security Agreement referred to below (in such capacity, the "Agent") for the benefit of The Lustro Company, an Illinois corporation ("Borrower").

WHEREAS, Borrower and the Agent are parties to that certain Trademark Security Agreement executed on August 20, 1996 and recorded on September 19, 1996 at the United States Patent and Trademark Office at reel 1495, frame 0102, by Borrower in favor of Agent (the "Trademark Security Agreement"); and

WHEREAS, Agent wishes to release and terminate its security interest, as granted in the Trademark Security Agreement, in:

(d) with respect to any and all of the foregoing, (i) the goodwill of the business symbolized thereby, (ii) all rights corresponding thereto throughout the world, (iii) all rights to sue for past, present and future infringement or dilution thereof or for any injury to goodwill, (iv) all licenses, claims, damages, and proceeds of suit arising therefrom, and (v) all payments and rights to payments arising out of the sale, lease, license assignment or other disposition thereof;

the aforementioned property hereinafter being referred to as the "Transferred Trademark."

NOW, THEREFORE, the undersigned Agent, who is the present holder and legal owner of the security interest in the Transferred Trademark granted by the Trademark Security Agreement, does hereby remise, release and quit claim the Transferred Trademark from the lien and security interest of the Trademark Security Agreement, whereby the Transferred Trademark are forever discharged from the lien and security interest of the Trademark Security Agreement.

TO HAVE AND TO HOLD the Transferred Trademark free, clear and discharged from the encumbrance of the security interest granted by the Trademark Security Agreement.
