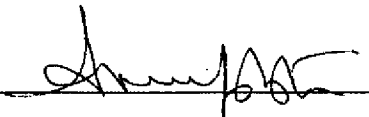

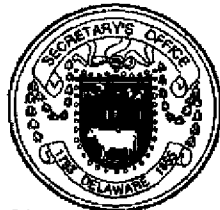

**CERTIFICATE OF AMENDMENT TO THE
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF IP UNITY GLENAYRE, INC.**

The undersigned, Oscar Rodriguez and Michael J. Danaher, certify that:

1. They are the President and the Assistant Secretary, respectively, of IP Unity Glenayre, Inc., a Delaware Corporation (the "Corporation").

2. The original Certificate of Incorporation of the Corporation was first filed with the Office of the Secretary of State of Delaware on December 8, 2006.

3. The Amended and Restated Certificate of Incorporation of the Corporation was filed with the Office of the Secretary of State of Delaware on December 29, 2006.

4. The Amended and Restated Certificate of Incorporation of the Corporation is amended as follows:

A. Article One is hereby amended to read in its entirety as follows:
