**AMENDMENT OF ARTICLES OF ORGANIZATION

“The name of the limited liability company is Misys Healthcare Systems, LLC.”


3. The amendment was duly adopted by the unanimous vote of the members of the limited liability company, or was adopted as otherwise provided in the limited liability company’s operating agreement.
