TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 2, 2010, by DYMAS FUNDING COMPANY, LLC, in its capacity as Administrative Agent for certain lenders ("Agent").

WITNESSETH:

WHEREAS, The Receivable Management Services Corporation, a Delaware corporation ("Grantor") executed and delivered in favor of Agent that certain Assignment for Security - Trademarks dated as of September 5, 2005 (the "Agreement"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "Trademarks") and Trademark Collateral (as defined below), including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 15, 2005, at Reel 003159, Frame 0975; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse, warranty or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and the Trademark Collateral.
