ARTICLES OF ASSOCIATION

We, Nathan Rogge and Lester Machado, certify that:


1. We are the President and the Secretary, respectively, of First Business Bank, N.A. (the "Bank") and that we have been duly appointed and are presently serving in those capacities in accordance with the Bylaws of the Bank.

2. At a meeting duly called on notice as required by law and convened on May 26, 2010, Article FIRST of the Bank's Articles of Association was amended and restated by the affirmative vote of a majority of the outstanding shares of the Bank's common stock, \$5.00 par value, entitled to vote thereon in accordance with 12 U.S.C. §21a, to read in its entirety as follows:


"FIRST. The title of this association shall be Bank of Southern California, National Association."

3. The foregoing amendment is presently in full force and effect as of the date hereof.
