## TRADEMARK ASSIGNMENT

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR makes the following assignment and agrees as follows:


**1. ASSIGNMENT.**

ASSIGNOR hereby assigns and sells to ASSIGNEE all of ASSIGNOR's rights, title and interest in and to the Trademark, together with the registration of the Trademark shown in Exhibit A, in and to all income, royalties, damages and payments now or hereafter due or payable with respect thereto and in and to all rights of action arising from the Trademark, all claims for damages by reason of past, present and future infringement of the Trademark and the right to sue and collect damages for such infringement, to be held and enjoyed by ASSIGNEE for its own use and benefit and for its successors and assigns as the same would have been held by ASSIGNOR had this assignment not been made, and the goodwill of the business symbolized by the Trademark.

**2. MISCELLANEOUS.** If any provision of this Assignment shall be adjudged by any court of competent jurisdiction to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that this Assignment shall otherwise remain in full force and effect and enforceable. This Assignment shall be deemed to have been made in, and shall be construed pursuant to the laws of the State of New York and the United States of America without regard to conflicts of laws provisions thereof.

**IN TESTIMONY WHEREOF**, ASSIGNOR and ASSIGNEE have executed this Assignment by their proper officers thereunto duly authorized.


