ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
E-BACKGROUNDCHECKS.COM ACQUISITION, INC.

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned Corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation.

ARTICLE I

The name of the Corporation is **E-BACKGROUNDCHECKS.COM ACQUISITION, INC.** (the "Corporation").

ARTICLE II

The following amendments to the Corporation's Articles of Incorporation were adopted by its Board of Directors on March 30, 2004:

1. ARTICLE ONE of the Articles of Incorporation shall be deleted in its entirety and in its place and stead shall be inserted the following provision:

"ARTICLE ONE

The name of the Corporation is e-backgroundchecks.com, Inc."

ARTICLE III


All other provisions of the Articles of Incorporation shall remain in full force and effect.

ARTICLE FOUR

The amendments in these Articles of Amendment to the Articles of Incorporation of the Corporation were adopted by a written unanimous consent of the shareholders of the Corporation on March 30, 2004. The number of shares of the Corporation outstanding at the time of such adoption was one million (1,000,000), and the number of shares entitled to vote thereon and which voted in favor of the amendment was one million (1,000,000).
