INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated as of July 16, 2009 ("Effective Date"), is entered into by and between Axentis, Inc., a Delaware corporation ("Assignor"), and CCH Incorporated, a Delaware corporation ("Assignee"). This Assignment is being entered into pursuant to that certain Asset Purchase Agreement dated as of the date hereof (as amended or supplemented in accordance with its terms, the "Purchase Agreement") by and between Assignor, Assignee, Wolters Kluwer International Holding B.V. and Scheltens & Gitlay B.V. Capitalized terms not otherwise defined herein shall have the meanings set forth in the Purchase Agreement.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignor hereby assigns to Assignee all of its right, title and interest in and to the Intellectual Property described on Schedule A attached hereto and to all other Intellectual Property used or held for use in or related to the conduct of the Business (collectively, the "Assigned IP"), in each case together with all rights associated therewith, including but not limited to the right to sue and collect for any past, present or future infringement, misappropriation or unauthorized use thereof, and any goodwill associated with any trademarks included therein.

2. In case at any time after the Effective Date any further action by either party hereto is reasonably necessary to carry out the purposes of this Agreement, each of the parties will take such further action (including but not limited to the execution and delivery of such further instruments and documents) as the other party may reasonably request, at the sole cost and expense of the requesting party.





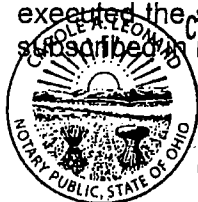
