## ASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, Organization Resources Counselors, Inc. ("ORC"), a Delaware corporation having an address of 500 Fifth Avenue, New York, New York 10110-0002, was the owner of all the intellectual property identified in Schedule A attached hereto and incorporated herein by reference (the "Assigned IP"); and

WHEREAS, pursuant to a Certificate of Ownership and Merger filed with the Delaware Secretary of State on July 30, 2010 at 7:25 p.m. Eastern Daylight Time, ORC merged with and into Mercer Inc. ("MINC"), a Delaware corporation having an address of 1166 Avenue of the Americas, 25<sup>th</sup> Floor, New York, New York 10036, causing MINC to become the owner of the Assigned IP by operation of law effective as of the time of such filing; and

WHEREAS, pursuant to an Assignment and Assumption Agreement between MINC and Mercer LLC ("MLLC"), a Delaware limited liability company, dated as of July 30, 2010 (the "MINC Assignment"), MLLC acquired from MINC all right, title and interest in and to the said Assigned IP together with the goodwill of the business symbolized by such intellectual property and the registrations thereof, effective as of July 30, 2010 at 7:40 p.m. Eastern Daylight Time; and

WHEREAS, pursuant to an Assignment and Assumption Agreement between MLLC and Mercer (US) Inc. ("MUS"), a Delaware corporation, dated July 30, 2010 (the "MLLC Assignment"), MUS acquired from MLLC all right, title and interest in and to the said Assigned IP together with the goodwill of the business symbolized by such intellectual property and the registrations thereof, effective as of July 30, 2010 at 7:50 p.m. Eastern Daylight Time; and

WHEREAS, ORC, MINC, MLLC, and MUS desire that the assignments of said intellectual property and registrations from ORC to MINC, from MINC to MLLC, and from MLLC to MUS, be made of record in the United States Patent and Trademark Office, and the United States Copyright Office, and any other appropriate governmental patent, trademark, and/or copyright offices;

NOW, THEREFORE, To All Whom It May Concern, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound:

(i) ORC assigned and transferred, pursuant to the Certificate of Ownership and Merger and by operation of law, unto MINC and its successors and assigns, effective as of July

30, 2010 at 7:25 p.m. Eastern Daylight Time, ORC's, entire right, title, and interest in and to the Assigned IP, together with the goodwill of the business symbolized by and associated with the Assigned IP, and the registrations thereof as set forth in Schedule A, to be held and enjoyed by MINC and its successors and assigns, as fully and entirely as the same would have been held and enjoyed by ORC had the merger with MINC not been effectuated;







(ii) MINC has assigned and transferred pursuant to the MINC Assignment, and by these presents does hereby sell, assign, transfer, and convey unto MLLC, its successors and assigns, effective as of July 30, 2010 at 7:40 p.m. Eastern Daylight Time, MINC's entire right, title, and interest in and to the Assigned IP, together with the goodwill of the business symbolized by and associated with the Assigned IP, and the registrations thereof as set forth in Schedule A, to be held and enjoyed by MLLC and its successors and assigns, as fully and entirely as the same would have been held and enjoyed by MINC had the MINC Assignment not been made;

(iii) MLLC has assigned and transferred pursuant to the MLLC Assignment, and by these presents does hereby sell, assign, transfer, and convey unto MUS, its successors and assigns, effective as of July 30, 2010 at 7:50 p.m. Eastern Daylight Time, MLLC's entire right, title, and interest in and to the Assigned IP, together with the goodwill of the business symbolized by and associated with the Assigned IP, and the registrations thereof as set forth in Schedule A, to be held and enjoyed by MUS and its successors and assigns, as fully and entirely as the same would have been held and enjoyed by MLLC had the MLLC Assignment not been made.

ORC, MINC, and MLLC, in their respective capacities as assignors, further transfer and assign to their respective assignees all causes of action, rights, and remedies which may have arisen under or which are arising under the Assigned IP prior to or after the effective times of their corresponding assignments, and all rights to damages and profits, due or accrued, arising out of any past infringement claims relating to the Assigned IP, and the right to sue for recovery of the same damages and profits.

This Assignment may be executed in any number of counterparts, each of which will constitute an original and all of which, when taken together, will constitute one agreement. Any signature page of this Assignment transmitted by facsimile will have the same legal effect as an original executed signature page.
