NUNC PRO TUNC TRADEMARK ASSIGNMENT

Nos. 77/866,891 and 77/436,677 for the marks  and MYCAR ("the Trademarks"), respectively, and the goodwill associated therewith;



Assignor also hereby represents that Assignee is the successor to the portion of Assignor's ongoing and existing business to which the Trademarks pertain.
