**TERMINATION AND RELEASE
OF SECURITY INTERESTS IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS, dated as of July 16, 2010 (this "Termination and Release"), is made by Toronto Dominion (Texas) LLC, in its capacity as U.S. collateral agent under the Credit Agreement referred to below (the "Collateral Agent"). Capitalized terms used and not otherwise defined herein shall have the meanings assigned to such terms in the Credit Agreement (as defined herein).

WHEREAS, the Collateral Agent entered into that certain Credit Agreement, dated as of October 30, 2006 (as amended and in effect from time to time, the "Credit Agreement"), among SFK Pulp Recycling U.S. Inc. (the "Grantor"), SFK Pulp Finco Inc., the lenders from time to time party thereto, the Collateral Agent, as U.S. Administrative Agent and U.S. Collateral Agent and The Toronto-Dominion Bank, a Canadian Bank, as Canadian Administrative Agent and Canadian Collateral Agent;

WHEREAS, the Grantor and the Collateral Agent entered into (i) that certain Term Trademark Collateral Security and Pledge Agreement, dated as of October 30, 2006 (as amended and in effect from time to time, the "Term Trademark Agreement") and (ii) that certain Revolver Trademark Collateral Security and Pledge Agreement, dated as of October 30, 2006 (as amended and in effect from time to time, the "Revolver Trademark Agreement" and together with the Term Trademark Agreement, the "Trademark Agreements");

WHEREAS, pursuant to the Credit Agreement, the Security Agreement (as defined in the Credit Agreement) and the Trademark Agreements, the Grantor granted to the Collateral Agent a continuing security interest in all of the Pledged Trademarks (as defined in each Trademark Agreement, respectively, and collectively known hereinafter as the "Trademarks");

WHEREAS, the Term Trademark Agreement was recorded with the United States Patent and Trademark Office on November 2, 2006 at Reel 3420, Frame 0763, and the Revolver Trademark Agreement was recorded with the United States Patent and Trademark Office on November 2, 2006 at Reel 3420, Frame 0785;

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its security interests in the Trademarks (including, without limitation those Trademarks identified on Exhibit A attached hereto) as herein provided;

NOW, THEREFORE, for valuable consideration, the Collateral Agent hereby terminates, releases and discharges its security interests in the Trademarks (including, without limitation those Trademarks identified on Exhibit A attached hereto) without representation, warranty or recourse of any kind or nature.
