RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of the [17th] day of September, 2010, by CapitalSource Finance LLC, having a business address at 4445 Willard Ave, 12th Floor, Chevy Chase, MD 20815 ("Secured Party") in favor of Alpha Packaging (Michigan) Inc., a Delaware corporation having a business address at 1555 Page Industrial Boulevard, St. Louis, Missouri 63132 ("Grantor").

WITNESSETH

WHEREAS, the Secured Party desires to grant to the Grantor a specific release of the security interest granted and recorded against each Trademark.

NOW THEREFORE, for the sum of \$10.00 and other good and valuable consideration previously tendered by the Grantor, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby terminate the Security Agreement and relinquish and release the entirety of the security interests in the Trademarks and reassigns forever to Grantor all right, title and interest of any nature whatsoever which the Secured Party holds in or to each Trademark and associated common law rights and goodwill appurtenant thereto, and further agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights to Grantor.
