RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release"), dated as of August 12, 2010, is made by **NEW STREAM SECURED CAPITAL, L.P.**, as grantee ("New Stream"), under the Intellectual Property Security Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Intellectual Property Security Agreement).

WHEREAS, in connection with that certain Loan and Security Agreement, dated as of July 30, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan and Security Agreement"), among **SNAPWARE CORPORATION**, as borrower and **NEW STREAM SECURED CAPITAL, L.P.**, as lender; and

WHEREAS, pursuant to the terms of that certain Intellectual Property Security Agreement dated as of July 30, 2008 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") and recorded with the United States Patent and Trademark Office on August 1, 2008 at Reel 003827, Frame 0499 (the "Security Agreement"), Grantor granted security interests in certain trademarks owned by Grantor including those listed on Annex I attached hereto (collectively, the "US Trademark Collateral"); and

WHEREAS, all of the outstanding Obligations under the Loan and Security Agreement (including, without limitation, all principal, accrued and unpaid interest, fees and expenses) have been repaid in full and New Stream wishes to release the security interest granted in the Intellectual Property Security Agreement;

NOW THEREFORE, in consideration of the foregoing, New Stream hereby **RELEASES** all of the security interests granted to New Stream under the Security Agreement in the US Trademark Collateral.

New Stream agrees, at the Loan Parties' expense, to cooperate with the Loan Parties and to provide the Loan Parties with the information and additional authorization reasonably required or desirable to effect the release of New Stream's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
