ASSIGNMENT OF TRADEMARK RIGHTS



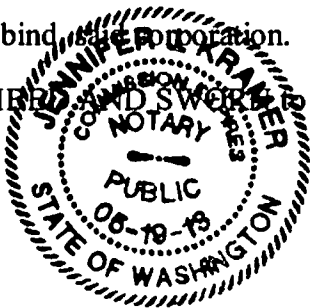

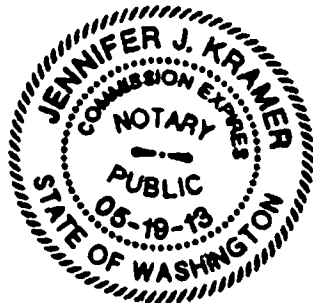
