## TRADEMARK ASSIGNMENT

WHEREAS, 19 Entertainment Limited ("Assignor"), a limited company having a place of business at 140 West 57<sup>th</sup> Street, 5<sup>th</sup> Floor, New York, New York 10019 ("Assignor"), is the owner and registrant of the trademark and service mark CARRIE UNDERWOOD in connection with various goods and services, such marks being registered under U.S. Registration No. 3,415,693 (the "Registration");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, Assignor hereby sells, assigns, and transfers to Assignee, absolutely and forever, the entire right, title and interest, throughout the world, whether statutory or at common law, in and to the Marks, together with the goodwill of the business symbolized by the Marks, and any corresponding registrations and applications, as well as all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.

Assignee agrees to file a Request to Divide Registration with respect to the Registration, pursuant to the foregoing.

Assignor agrees to execute any further papers as may be necessary and proper to vest full title in and to the Marks and other corresponding rights in the Assignee.

Assignor hereby consents to the recordation of this assignment in any applicable country.

Assignor represents and warrants that it is the owner of the Marks, and has not previously transferred or otherwise encumbered the rights being assigned to Assignee.

Assignee hereby accepts the assignment of the Marks, the applications and registrations applicable thereto and all other rights described in this assignment.

The individuals signing this document on behalf of corporate entities represent and declare that they are authorized to execute this document on behalf of such corporate entities.
