**GRANT OF SECURITY INTEREST

This Security Grant has been given in conjunction with security interest granted to the Administrative Agent under the Security Agreement, and the provisions of this Security Grant are not intended to limit, restrict, supplement or amplify the provisions of the Security Agreement, which are incorporated herein by this reference.



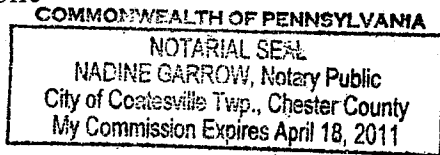
