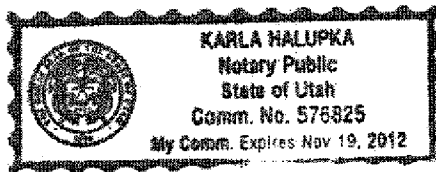
said Assignee or its attorneys be reasonably required to aid said Assignee to obtain full protection for said Trademark.
