ARTICLES OF AMENDMENT

THIS IS TO CERTIFY THAT:

FIRST: That charter of Onsite Companies, Inc., a Maryland corporation (the "Corporation"), is hereby amended by deleting the existing Article Second and inserting a new Article Second in lieu thereof to read as follows:

"SECOND: The name of the Corporation (which is hereafter called the "Corporation") is:

SECOND: The amendment to the charter of the Corporation as set forth above was approved by a majority of the entire Board of Directors of the Corporation and such amendment is limited to a change expressly authorized by Section 2-605 of the Maryland General Corporation Law to be made without action by the stockholders of the Corporation.
