## ASSIGNMENT OF TRADEMARK

This Assignment of Trademark ("Assignment") is entered this 15 day of September, 2010 by and between Nutra-Flo Company, an Iowa Corporation ("Assignor") whose address for purposes of this Assignment is 1919 Grand Avenue, Sioux City, IA 51106 and Nutraferma, Inc., a Delaware Corporation ("Assignee") whose address for purposes of this Assignment is 1919 Grand Avenue, Sioux City, IA 51106.

**WHEREAS**, Assignor is the owner of the trademark "Nutraferma" (the "Trademark") as set forth in Registration No. 3,503,199 registered September 16, 2008 with the United States Patent and Trademark Office (the "Trademark Registration"); and

**WHEREAS**, Assignor wishes to assign the Trademark and Assignee wishes to take assignment of the Trademark.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. **Assignment**. Assignor assigns, conveys and transfers to Assignee all its right, title and interest in and to the Trademark Registration and the Trademark together with (a) all goodwill associated with the Trademark Registration and the Trademark; (b) all income, royalties and damages hereafter due or payable to Assignor with respect to the Trademark, including without limitation damages and payments for past or future infringements and misappropriations of the Trademark; and (c) all rights to sue for past, present and future infringements or misappropriations of the Trademark.
2. **Recording**. Assignor and Assignee agree to record the assignment of the Trademark Registration and Trademark with the United States Patent and Trademark Office. Assignee shall pay all costs associated with recording the assignment.
3. **Further Assurances**. Assignor agrees to execute all documents, papers, forms and authorizations and take all other actions necessary for securing, completing or vesting in Assignee full right, title and interest in the Trademark Registration and Trademark.
4. **Miscellaneous**. This Assignment shall be binding upon the heirs, administrators, successors, and assigns of any and all parties hereto. This Assignment contains the entire understanding of the parties with respect to the subject matter hereof. The law of the State of Iowa shall govern and be applied in the interpretation and enforcement of this Assignment.
