RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

29th This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT is made this day of September, 2010, by **ROYAL BANK OF CANADA**, a Canadian chartered bank (together with its successors and assigns, "Grantee"), acting through a branch located at One Liberty Plaza, New York, New York.
