ARTICLES OF AMENDMENT TO THE
AMENDED AND RESTATED CHARTER OF
INTEGRATED VOICE SOLUTIONS, INC.

Pursuant to the provisions of Section 48-20-106 of the Tennessee Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment (the "Articles of Amendment") to its Amended and Restated Charter (the "Charter"):

1. Name of Corporation. The name of the Corporation is Integrated Voice Solutions, Inc.

2. Article I of the Charter is hereby deleted in its entirety and replaced with the following:

"I. The name of the corporation is Vocera Hand-Off Communications, Inc."

3. Except as amended by these Articles of Amendment, the Charter of the Corporation shall remain in full force and effect.

4. Adoption. These Articles of Amendment were duly adopted by the Corporation's sole shareholder on September 20, 2010.

5. Effective Date. These Articles of Amendment will be effective when filed with the Secretary of State.
