RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST is made as of September 30, 2010, by Mizuho Corporate Bank, Ltd., a Japanese banking corporation, as successor-in-interest to The Industrial Bank of Japan, Limited, as collateral agent (“**Collateral Agent**”) under that certain Security Agreement, dated as of July 24, 2001 (the “**Assignment**”), pursuant to which Extended Stay America, Inc. (the “**Grantor**”) granted a security interest to Collateral Agent in certain trademark collateral (the “**Trademarks**”), including the trademark registrations and applications set forth on Schedule A, as security for certain obligations owing by Grantor under that certain Credit Agreement, dated as of July 24, 2001 between Grantor and the lender parties thereto (the “**Credit Agreement**”).

WITNESSETH:

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on and on August 10, 2001, at and Reel 2350, Frame 0718 and on September 6, 2001, at Reel 2365, Frame 0543; and

WHEREAS, Extended Stay Inc., as successor in interest to Grantor (“**ESI**”), has requested that Collateral Agent release its security interest in the Trademarks and Trademark Rights and reassign the same to ESI.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Rights**”):

(i) the Trademarks, including each Trademark and application for Trademark listed on Schedule A annexed hereto, together with any extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor or ESI against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Collateral Agent hereby reassigns, grants and conveys to ESI, all of Collateral Agent’s right, title and interest in and to the Trademarks and the Trademark Rights.
