TRADEMARK ASSIGNMENT

This is an Assignment by WORLDWAYS, INC., a Colorado corporation, ("ASSIGNOR") having an address of 8100 East Maplewood Avenue, Suite 110, Greenwood Village, Colorado 80111, to COUNTY OF SANTA CLARA, ("ASSIGNEE") having an address of 70 West Hedding Street, San Jose, CA 95110.

NOW, THEREFORE, in consideration of the sum of two thousand seven hundred dollars (\$2,700.00 USD) (which represents reimbursement of ASSIGNOR's legal fees for trademark registration of the Logo as of April 8, 2010) and certain other good and valuable consideration paid to ASSIGNOR the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby grant, transfer, assign and convey its entire right, title and interest in and to the Logo shown on Exhibit A, all associated goodwill of the business, the right to sue for past infringement, and U.S. Trademark Registration No. 3,748,907.


ASSIGNOR shall assist ASSIGNEE with the recordation of this ownership transfer with the United States Patent and Trademark Office.

ASSIGNEE acknowledges that other entities have purchased licensed rights to use the Logo and agrees to allow them to permanently continue doing so without interruption or interference. ASSIGNEE further agrees that it intends to surrender the Logo into the public domain and will not sell, license, or transfer ownership of the Logo to a third party or use the Logo for commercial purposes. ASSIGNOR is transferring its rights based on the understanding that the Logo will be in the public domain.
