RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE is made as of this 20th day of August, 2010, in favor of Picis, Inc., a Delaware corporation (the "Company"), by Wells Fargo Capital Finance, Inc., a California corporation (formerly known as Wells Fargo Foothill, Inc.), as Collateral Agent ("Wells") under that certain Credit and Guaranty Agreement, dated as of August 8, 2007 and as amended to date, by and among Wells, as Administrative Agent and Collateral Agent, the lenders party thereto, Picis Solutions, Inc., the Company, Picis (Wisconsin), Inc., Lynx Medical Systems Holding Corp. and Lynx Medical Systems, Inc.


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Wells hereby unconditionally and expressly terminates the Trademark Security Agreements (as defined below) and releases, terminates, and extinguishes any and all of its right, title and interest in and to, and all liens and security interests it may have upon, the Trademark Collateral (as defined in that certain Trademark Security Agreement, dated August 8, 2007, by and between Goldman Sachs Specialty Lending Group, L.P. ("Goldman") and Company and as modified by that certain Resignation and Appointment of Agent Under Trademark Security Agreement, dated as of August 15, 2008, by and between Goldman and Wells; that certain First Amendment to Trademark Security Agreement, dated August 19, 2008, made by Company in favor of Wells; that certain Pledge Supplement, dated June 16, 2009, made by Company in favor of Wells; that certain Pledge Supplement, dated July 1, 2009, made by Company in favor of Wells; and that certain Pledge Supplement, dated April 27, 2010, made by Company in favor of Wells (collectively, the "Trademark Security Agreements")), including, without limitation, those

trademarks and trademark applications specifically listed on Exhibit A attached hereto and the goodwill associated therewith (collectively, the "Marks").

Wells consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon the Marks.

This Release shall be binding upon Wells' legal representatives, assigns and successors.
