**RELEASE OF SECURITY INTEREST IN TRADEMARK, COPYRIGHT AND PATENT**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK, COPYRIGHT AND PATENT (this "Release") is made as of September 30, 2010 ("Effective Date") by GENERAL ELECTRIC CAPITAL CORPORATION, in its capacity as Lender ("Grantee"), in favor of ARGON MEDICAL DEVICES, INC. ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated as of April 30, 2010 (the "2010 IP Security Agreement"), Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantor's right, title and interest in and to the Collateral;

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement, dated on or about December 26, 2006 (the "2006 IP Security Agreement" and together with the 2010 IP Security Agreement, the "IP Security Agreements"), Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantor's right, title and interest in and to the Collateral;

WHEREAS, the 2010 IP Security Agreement was recorded with the United States Patent and Trademark Office on May 5, 2010 at Reel 024337, Frame 0278 and at Reel 004199, Frame 0297, and on May 6, 2010 at Reel 4200, Frame 0058 and at Reel 024342, Frame 0224 and the 2006 IP Security Agreement was recorded with the United States Patent and Trademark Office on December 26, 2006 at Reel 3450, Frame 0482; and

WHEREAS, Grantee has consented to the release of the Lien on the Collateral listed on Schedule 1 hereto (the "Intellectual Property Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Intellectual Property Collateral granted pursuant to the IP Security Agreements is hereby terminated and released.

2. To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantor, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Intellectual Property Collateral. Such assignment, transfer and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantor.
