THIS AGREEMENT AND DEED OF ASSIGNMENT is made the 10th day of March 2010.

WHEREAS:

The Assignor is the proprietor of the Trademark **JOBE** in the **United States of America**, Registration No. **1041388** and **Canada**, Application no. **1,443,988** and the rights attached thereto and the goodwill associated therewith, including all rights related to the use, registration or application for registration of this trademark (hereinafter referred to as "The Trademark").

The Assignor has agreed to sell and assign to the Assignee and the Assignee has agreed to buy and accept The Trademark and the goodwill relating to The Trademark on the terms and conditions set out in this Agreement and Deed of Assignment.

NOW THIS DEED WITNESSES:

Assignor hereby sells and assigns to the Assignee who hereby buys and accepts for the sum of € 1,00 (one Euro) now paid by the Assignee to the Assignor (the receipt whereof the Assignor hereby acknowledges) ALL the right, title and interest in The Trademark including all common law rights connected with The Trademark and the right for the Assignee to take proceedings to recover damages and claim all other relief in respect of any infringement of The Trademark, whether any such act shall have taken place before or after the date of this Agreement and Deed of Assignment.

This Agreement and Deed of Assignment are being made together with an assignment of the goodwill of the business relating to the goods and/or services in respect of which The Trademark is used and/or registered and/or applied for registration.

At the request and at the expense of the Assignee, the Assignor will do all reasonable acts, execute all documents and procure the making of any declarations or oaths necessary or required by law for further effecting the assignment of The Trademark to the Assignee and assisting the Assignee in recording the assignment of The Trademark.


This Agreement and Deed of Assignment is governed by the laws of The Kingdom of The Netherlands.
