ASSIGNMENT OF TRADEMARK

WHEREAS, Henry Schein, Inc., a corporation organized and existing under the laws of Delaware, having its principal place of business at 135 Duryea Road, Melville, New York 11747 (hereinafter referred to as "ASSIGNOR"), is the owner of an intent-to-use U.S. trademark application for TELESTAT (and Design) (Application No. 77/614,490) filed on November 14, 2008 for "Medical tele-monitoring devices for monitoring patients' conditions, activities, and pharmaceutical regimens, and for alerting patients or healthcare professionals of status, changes, and emergencies" in Class 10 (hereinafter referred to as the "TRADEMARK"); and

WHEREAS, HS TM, LLC, a Delaware limited liability company having a principal place of business at 220 Continental Drive, Suite 115, Newark, Delaware 19713 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring all of the right, title and interest of ASSIGNOR in, to and under the TRADEMARK, together with the goodwill of the business associated with the TRADEMARK.

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged:

ASSIGNOR hereby transfers to ASSIGNEE the entire right, title and interest of ASSIGNOR in and to the TRADEMARK together with the goodwill of the business associated with the TRADEMARK and Application No. 77/614,490; and

ASSIGNEE agrees that it shall use commercially reasonable efforts to promote the TRADEMARK. In the event that a court of law makes a final determination that ASSIGNEE did not use commercially reasonable efforts to promote the TRADEMARK, ASSIGNEE agrees to relinquish its rights in the TRADEMARK back to ASSIGNOR; and


ASSIGNOR, does hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representative; and

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, to record the trademark Application No. 77/614,490 as property of ASSIGNEE; and

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARK and the application herein assigned.


