TRADEMARK SECURITY AGREEMENT

Trademark Security Agreement, dated as of September 30, 2010 (as amended, restated or otherwise modified, the "*Trademark Security Agreement*"), between each of WM. WRIGLEY JR. COMPANY, a Delaware corporation, NORTHWESTERN FLAVORS, LLC, an Illinois Limited Liability Company, L.A. DREYFUS COMPANY, a Delaware Corporation, and LUCAS WORLD, INC., a Delaware Corporation (collectively, "*Grantors*") and COÖPERATIEVE CENTRALE RAIFFEISEN-BOERENLEENBANK B.A., "RABOBANK NEDERLAND", NEW YORK BRANCH, in its capacity as collateral agent for the First Lien Secured Parties (together with successors and assigns in such capacity, the "*Collateral Agent*").

Witnesseth:

WHEREAS, pursuant to the Second Amended and Restated Credit and Guaranty Agreement dated as of June 28, 2010 (the "*Credit Agreement*"), the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower (in each case, as such terms are defined therein) upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, each of the Grantors and certain other subsidiaries of the Borrower have executed and delivered the Amended and Restated Pledge and Security Agreement dated as of June 28, 2010 in favor of the Collateral Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "*Pledge and Security Agreement*");

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantors pledged and granted to the Collateral Agent for the benefit of the Agent and the Lenders a continuing security interest in all Intellectual Property, including Trademarks and Trademark Licenses; and

WHEREAS, the Grantors have duly authorized the execution, delivery and performance of this Agreement;

NOW, THEREFORE, in consideration of the premises and the agreements, provisions and covenants contained in the Pledge and Security Agreement, the Grantors hereby agree with the Collateral Agent, as follows:

SECTION 1. DEFINED TERMS. Unless otherwise defined herein, terms defined in the Pledge and Security Agreement and used herein have the meaning given to them in the Pledge and Security Agreement.

SECTION 2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Each Grantor hereby grants to Collateral Agent, for the benefit of the First Lien Secured Parties, a security interest in and continuing lien on all of such Grantor's right, title and interest in, to and under the following, in each case whether now owned or existing or hereafter acquired or arising and wherever located (collectively, the "*Trademark Collateral*"):

(a) all United States, and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certifications marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing, including, but not limited to: (i) the registrations and applications referred to on Schedule I hereto, (ii) all extensions or renewals of any of the foregoing, (iii) all of the goodwill of the business connected with the use of and symbolized by the foregoing, (iv) the right to sue for past, present and future infringement or dilution of

any of the foregoing or for any injury to goodwill and (v) all Proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages and proceeds of suit (collectively, "**Trademarks**"); and

(b) any and all agreements, licenses and covenants providing for the granting of any right in or to Trademarks or otherwise providing for a covenant not to sue or permitting co-existence (whether such Grantor is licensee or licensor thereunder), including, without limitation, each agreement listed on Schedule II hereto (collectively, "**Trademark Licenses**");

provided, that Excluded Assets shall not constitute Trademark Collateral.

SECTION 3. SECURITY AGREEMENT. The security interest granted pursuant to this Trademark Security Agreement is made solely to record the security interest granted to the Collateral Agent for the First Lien Secured Parties pursuant to the Pledge and Security Agreement. Grantors hereby acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Pledge and Security Agreement, the provisions of the Pledge and Security Agreement shall control.

SECTION 4. APPLICABLE LAW. This Trademark Security Agreement and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflicts of law provisions thereof (other than New York General Obligations Law, Section 5-1401 and any mandatory provisions of the UCC relating to the law governing perfection and the effect of perfection of the security interest).

SECTION 5. COUNTERPARTS. This Trademark Security Agreement may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
