**TERMINATION AND RELEASE
OF
TRADEMARK SECURITY AGREEMENT**

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of September 22, 2010, by and between MAGIC CARD INTERNATIONAL, INC., a Florida corporation with its principal place of business at 2424 N. Federal Highway, Suite 411, Boca Raton, FL 33431 (the "Pledgor") and CELEBRITY CARDS INTERNATIONAL, INC., a Florida corporation with its principal place of business at 1901 Harrison Street, Suite 208, Hollywood, Florida 33020 (the "Company").

WHEREAS, pursuant to the terms of Security Agreement, dated July 1, 2004, between the Company and the Pledgor (the "Security Agreement") and recorded with the U.S. Patent and Trademark Office on August 13, 2004, at Trademark Reel 3028 and Frame 0493, the Company granted to the Pledgor a security interest in and lien on, and collaterally assigned to the Pledgor all of its trademarks, trademark registrations and associated goodwill, including, without limitation, the trademarks identified on Schedule A attached hereto (such trademarks referred to herein as the "Named Trademarks") and the domain name identified on Schedule A attached hereto (such domain name referred to herein as the "Named Domain"); and

WHEREAS, the Pledgor has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks and Named Domain as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Pledgor and the Company hereby agree as follows:

1. Release and Assignment. The Pledgor hereby terminates and releases its security interest in and first priority lien on all of the Company's Named Trademarks and Named Domain, and the Pledgor hereby assigns and transfers to the Company, without recourse, all of the Pledgor's right, title and interest in and to each of the Named Trademarks and Named Domain and the related trademark registrations and goodwill, effective as of the date set forth above.
2. Acknowledgment and Acceptance. The Company hereby acknowledges and accepts the foregoing release and assignment by the Pledgor.
3. Counterparts. This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.

IN WITNESS WHEREOF, the Pledgor and the Company have executed this Release, to take effect as of the date first set forth above.

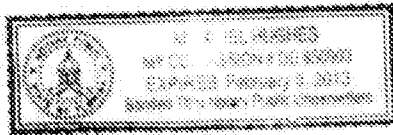
