ASSIGNMENT OF TRADEMARK

McNally Industries, Inc., a Minnesota corporation ("Assignor"), is the owner of the following trademark (the "Mark") registered with the U.S. Patent and Trademark Office:

Pursuant to a certain Asset Purchase Agreement dated December 31, 2002, Assignor assigns to McNally Acquisition, LLC, a Delaware limited liability company ("Assignee"), its entire right, title and interest in and to the Mark together with the goodwill of the business symbolized by the Mark and its registration, with all rights of action, powers and benefit to the Mark, due or accrued, including the right to sue for and recover in the Assignee's own name and that of its successors. Assignor assigns, and other legal representatives, all remedies of every nature, including without limitation rights to injunctive relief, damages, profits, costs and attorney fees, arising out of past infringement of the Mark, or injury to the related goodwill, *nunc pro tunc*, effective as of December 31, 2002.
