The undersigned, being the President of Ethox Corp., a New York corporation (the "Corporation"), does hereby certify:

- 1) Pursuant to a Certificate of Amendment filed by the Department of State on November 1, 1976, the name of the Corporation was changed from "Ethylox Products, Inc." to "Ethox Corp."
- 2) The Certificate of Incorporation of the Corporation under the name "Ethylox Products, Inc." was filed by the Department of State on April 22, 1966.
- 3) The Certificate of Incorporation of the Corporation is amended to change the name of the Corporation to "Ethox International, Inc." Paragraph FIRST of the Certificate of Incorporation is amended to read as follows:  
  
FIRST: The name of the Corporation is "Ethox International, Inc."
- 4) The foregoing amendment was authorized by the written consent of the Board of Directors of the Corporation, followed by the unanimous written consent of the holder of all outstanding shares of the capital stock of the Corporation entitled to vote.
