**ASSIGNMENT AND ASSUMPTION AGREEMENT REGARDING
CERTAIN TRADEMARKS**

This ASSIGNMENT AND ASSUMPTION AGREEMENT ("Agreement") is made and entered into effective as of the 28th day of December, 2001, by and between DREXEL HERITAGE FURNISHINGS INC., a New York corporation ("Assignor") and DHI FURNITURE, INC., a Delaware corporation ("Assignee").

WITNESSETH:

WHEREAS, pursuant to Section 2.11 of the Asset Purchase Agreement dated effective December 4, 2001, by and among the parties to this Agreement, Assignor is to assign to Assignee Assignor's rights, title and interests in certain Trademarks, and Assignee is to assume Assignor's obligations thereunder,

NOW, THEREFORE, for the sum of \$10.00 and other good and valuable consideration described in the Asset Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, bargain, sell, convey, and transfer to Assignee all of Assignor's worldwide rights, titles, and interests in, and Assignee does hereby assume responsibility for, and agree to perform, pay and discharge, as and when due, all related liabilities and obligations arising as of or after the Closing Date, in each case with respect to the Trademarks listed on Schedule A attached hereto, and their respective Trademark applications and registrations, together with that portion of the goodwill of the business with which the Trademarks presently are used by Assignor and which is symbolized by the Trademarks, including any causes of action relating to violations of such Trademarks, and licenses with respect to the Trademarks listed on Schedule A.

Assignor and Assignee shall from time to time, upon the written reasonable request of the other party, promptly execute and deliver any and all such further instruments and documents as the requesting party may reasonably deem desirable in order to realize the full benefit of this Agreement and of the rights and powers set forth herein.


This Agreement shall be governed by, and construed in accordance with, the laws of the State of Delaware, without giving effect to procedural rules or legal principles respecting conflicts of law.

Capitalized terms not specifically defined herein shall have the meanings ascribed to them in the Asset Purchase Agreement.
