RELEASE OF SECURITY AGREEMENTS

This RELEASE OF SECURITY AGREEMENTS (this “*Release*”), dated October 6, 2010, is made by JPMorgan Chase Bank, N.A. (f/k/a JPMorgan Chase Bank and f/k/a The Chase Manhattan Bank) as administrative agent for the lenders (“*Assignor*”) in favor of B&B COMPANY (successor in interest to SPYGLASS ENTERTAINMENT GROUP, LLC and CYPRESS ENTERTAINMENT GROUP, L.P. via change of name and assignment), as Assignee/ Borrower (“*Assignee*”) (unless otherwise defined below, all capitalized terms in this Release shall have the definitions accorded to them in the Security Agreements referred to below.)

WHEREAS, Assignor and Assignee entered into that certain “CREDIT, SECURITY, GUARANTY AND PLEDGE AGREEMENT” dated as of December 18, 1998, as amended and restated as of March 30, 2004, that “TRADEMARK SECURITY AGREEMENT” dated as of June 11, 1999 (the “*Trademark Security Agreement*”) and “SUPPLEMENT NO. 1 TO THE TRADEMARK SECURITY AGREEMENT” dated as of July 17, 2001 (the “*Supplemental Trademark Security Agreement*”) (collectively, the “*Security Agreements*”), in each case granting to Assignor a security interest in the Trademark Collateral (as defined in the Security Agreements).

WHEREAS, the Supplemental Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office against Trademark Collateral identified therein at Reel 2365; Frame 0750 on August 29, 2001.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agrees as follows:

Assignor hereby releases and conveys to Assignee, without recourse, representation or warranty of any kind, express or implied, all of Assignor’s right, title and interest in and to the Trademark Collateral, including, but not limited to, the Trademark Collateral listed on attached Schedule A.

Assignor authorizes and requests that the Commissioner for Patents and Trademarks record this Release and index it against the works referenced on Schedule A.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York and to the extent applicable, the Bankruptcy Code.



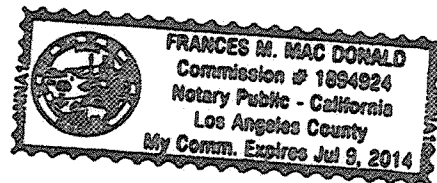
