WHEREAS, **ASSIGNEE** is desirous of obtaining **ASSIGNOR**'s entire right, title and interest in and to the **Intellectual Property**;

NOW, THEREFORE, in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, **ASSIGNOR** has, on said Effective Date, sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto the said **ASSIGNEE**, its successors, legal representatives and assigns, **ASSIGNOR**'S entire right, title and interest in and to said **Intellectual Property**, including **ASSIGNOR**'S rights and interests in and to any and all: (i) patents and patent applications, including those set forth in Schedule 1, and the inventions disclosed therein, and any and all divisions, renewals and continuations thereof, and all Letters Patent which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the

United States, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof, and statutory invention registrations in any jurisdiction; (ii) trade secrets; (iii) know-how; (iv) designs; (v) engineering drawings; (vi) operational and technical documents; (vii) copyrights, whether or not registered, including all common law rights thereto; and (viii) trademarks and service marks, including those identified in Schedule 1, together with the goodwill of the business symbolized by said trademarks and service marks, and any portion of said business to which said marks pertain, if the same is ongoing and existing, trade dress, whether registered or existing in common law, and all applications and registrations therefor; and
