Pursuant to Sections 14A:2-2(a) and 14A:2-4(b)

of the New Jersey Business Corporation Act

Dated: July 11, 2008

The undersigned corporation, having adopted an amendment to its certificate of incorporation pursuant to Sections 14A:2-2(a) and Section 14A:2-4(b) of the New Jersey Business Corporation Act, hereby certifies that:

1. The name of the corporation is **CFO MEDICAL SERVICES, P.A.** The corporate identification number of the corporation is **0100853567.**

2. Article I of the corporation's certificate of incorporation is deleted in its entirety and the following new Article I shall be inserted in lieu thereof:

"FIRST: The name of the corporation is **CFO MEDICAL SERVICES, INC."**

2. Article II of the corporation's certificate of incorporation is deleted in its entirety and the following new Article II shall be inserted in lieu thereof:

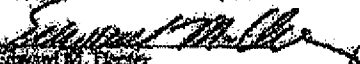
"SECOND: The purpose for which this corporation is organized is to engage in any activity within the purposes for which corporations may be organized under the New Jersey Business Corporation Act."

3. The date the amendment to the certificate of incorporation was adopted by the board of directors and thereafter duly adopted by the shareholders of the corporation was **May 31, 2008.**

4. That in lieu of a meeting and vote of the shareholders and in accordance with the provisions of Section 14A:2-6, the amendment was adopted by the shareholders without a meeting pursuant to the written consent of the shareholders and the number of shares represented by such consent is **1187 shares.**
