TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") made as of October 1, 2010 (the "Effective Date") is by NexBank, SSB, as Agent (in such capacity, "Agent"), for the benefit of Marcal Paper Mills, LLC ("Grantor").

WHEREAS, pursuant to (a) that certain First Lien Trademark Collateral Assignment And Security Agreement, dated as of May 30, 2008 (the "First Security Agreement"; capitalized terms used herein and not otherwise defined herein shall have the respective meanings set forth in the First Security Agreement), recorded in the United States Patent and Trademark Office at Reel 3786, Frame 0584 on June 2, 2008; and (b) that certain Second Lien Trademark Collateral Assignment And Security Agreement, dated as of May 30, 2008 (the "Second Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 3786, Frame 0817 on June 2, 2008, Grantor granted to Agent, for itself and the ratable benefit of Secured Parties, a continuing security interest in and a general lien upon all of Grantor's right, title and interest in and to the trademark registrations listed on Schedule 1 hereto (the "Trademarks"); and

WHEREAS, Grantor has requested and Agent desires to terminate such security interest and provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:


