ASSIGNMENT OF INTELLECTUAL PROPERTY AGREEMENT

This Assignment of Intellectual Property Agreement (this "Agreement") is effective as of October 1, 2010, by and between Money Transfer Acquisition Inc. (the "Assignor") and Dolex Dollar Express, Inc. (the "Assignee").

WHEREAS, pursuant to that certain Asset Purchase Agreement of even date herewith by and among the Assignor; Latinvest Investment Company II, LLC; Remesas Quisqueyana, Inc. ("RQI"); Latintel, Inc.; Quisqueyana Tax, Inc.; and Quisqueyana Travel, Inc. (the "Agreement"), Assignor has acquired the Intellectual Property Assets (as defined in the Agreement, and as further described below) of RQI;

WHEREAS, Assignor wishes to assign to Assignee all of Assignor's right, title and interest in and to any intellectual property rights as listed in Schedules 3.25(e) and 3.25(h) (the "IP Disclosure Schedules") of the Sellers' Disclosure Letter to the Agreement, which is incorporated by reference herein;

NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. Assignment. Assignor hereby assigns to Assignee all of Assignor's right, title, benefit, privileges and interest in and to any intellectual property rights listed in the IP Disclosure Schedules, which shall include all inventions, works of authorship, developments, concepts, know-how, discoveries, ideas, improvements, trademarks or trade secrets, whether or not patentable or registrable under copyright, trademark or similar laws, made or obtained by Assignor relating to its business, and any goodwill associated therewith, and all contract rights and causes of action with respect to the foregoing, throughout the world (the "Assigned Intellectual Property").

2. Further Assurances. Upon the request of Assignee, Assignor will execute and deliver all documents and do other acts which are or may be necessary to document the assignment described herein, or to enable Assignee to file and prosecute applications for and to acquire, maintain, extend and enforce any and all patents, trademark registrations or copyrights or applications therefore in connection with the Assigned Intellectual Property under United States or foreign law.


3. Governing Law. This Agreement and all the rights and obligations of the parties hereunder, shall be governed by and construed in accordance with the laws of the State of New York, without regard to the principles of conflicts or choice of laws rules.

4. Counterparts. This instrument may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
