**NUNC PRO TUNC ASSIGNMENT OF UNITED STATES TRADEMARK**

ASSIGNEE may deem necessary or desirable for securing to ASSIGNEE or for maintaining for ASSIGNEE the Trademark assigned, all without further compensation to ASSIGNOR.
