**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** (this "Termination and Release"), dated as of October 1, 2010, is made by **WILMINGTON TRUST FSB**, a federal savings bank, located at 50 South Sixth Street, Suite 1290, Minneapolis, MN 55402 (the "Administrative Agent"), in favor of **VISTEON CLIMATE CONTROL SYSTEMS LIMITED**, a Delaware corporation, located at 1 Village Center Drive, Van Buren Township, MI 48111 (the "Grantor").

**WITNESSETH:**

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated June 13, 2006 ("Trademark Agreement"), Grantor granted to JPMorgan Chase Bank, N.A. ("Predecessor Agent"), for itself and for the ratable benefit of certain secured parties, a security interest in the Trademark Collateral (as defined in the Assignment of Security Interest defined below), including those trademark registrations set forth on Schedule A attached hereto;

WHEREAS, pursuant to that certain Successor Agent Agreement and Amendment dated April 15, 2009 and that certain Assignment of Security Interest in Trademarks dated April 15, 2009 ("Assignment of Security Interest"), Predecessor Agent assigned all of its rights, powers, privileges and obligations under the Trademark Agreement to the Administrative Agent;

WHEREAS, the Assignment of Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on April 21, 2009 at Reel 003973, Frame 0976 for the purpose of providing Trademark Collateral as collateral security for the payment and performance of certain obligations of the Grantor to the Administrative Agent;

WHEREAS, Grantor has paid all of its outstanding obligations to the Administrative Agent; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges any and all security interest it has against the Trademark Collateral without representation, warranty or recourse of any kind or nature.

The Administrative Agent shall, at Grantor's sole cost and expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Termination and Release.
