## CONFIRMATORY TRADEMARK ASSIGNMENT AGREEMENT

**WHEREAS, Lakeside Copy and Blueprinting Co., (dba Lakeside Blueprint, Inc.),** an Ohio corporation formerly doing business at 3666 Carnegie Ave, Cleveland, OH 44115 (“Assignor”), was the original owner of the mark EBLUEPRINT (the “Mark”) that issued to registration in the United States on October 12, 2004 under Reg. No. 2,893,941 in connection with “*Providing information, via a global computer network, relating to copying services, printing supply sales and printer sales*” in Class 35 (the “Registration”);

**WHEREAS, American Reprographics Company, L.L.C.,** a California limited liability company doing business at 1981 N. Broadway, Suite 385, Walnut Creek, CA 94596 (“Assignee”) desired to acquire the Mark and Registration and the goodwill of Assignor’s business symbolized by the Mark;

**WHEREAS,** the Mark and the Registration were subject to an Asset Purchase Agreement dated October 2007 between and among the Assignor and Assignee and other parties;

**WHEREAS,** Assignor has heretofore sold, assigned, and transferred to Assignee its entire right, title, and interest in and to the Mark and the Registration therefore, together with the goodwill of Assignor’s business symbolized by the Mark;

**WHEREAS,** Assignee desires this Confirmatory Assignment for the purpose of recording its ownership of the above-identified Mark and Trademark Registration therefore at the United States Patent and Trademark Office.

**NOW THEREFORE,** for good and valuable consideration, already received and hereby acknowledged, Assignor does hereby assign, transfer, and confirm unto Assignee all of Assignor’s right, title, and interest in and to the Mark and the Registration therefore, including all common-law rights, together with that portion of Assignor’s business to which the Mark and Registration pertains, and that portion of the goodwill of Assignor’s business symbolized by the Mark, as well as the right to sue for past infringement thereof.
