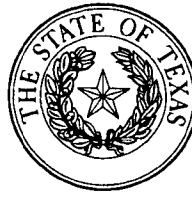

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION**

Pursuant to the provisions of article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

ARTICLE ONE

The name of the corporation is OWEN HEALTHCARE, INC.

ARTICLE TWO

The following amendment to the articles of incorporation was adopted by the shareholders of the corporation on November 15, 2002. The articles of incorporation are amended to change the name of the corporation to CARDINAL HEALTH 109, INC.

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.
