INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Assignment") is entered into as of September 14, 2010 (the "Effective Date") by and between Wolters Kluwer Pharma Solutions, Inc., a Delaware corporation ("Assignor") and Fairview Research, LLC, a Connecticut limited liability company ("Assignee"), pursuant to that certain Asset Purchase Agreement dated as of the date hereof by and between Assignor and Assignee (the "Purchase Agreement").

All capitalized terms used and not otherwise defined herein have the respective meanings ascribed to such terms in the Purchase Agreement.

This Assignment is subject to all of the terms, conditions and limitations set forth in the Purchase Agreement (including the representations, warranties, covenants and indemnities set forth in the Purchase Agreement). In the event of any conflict or inconsistency between the terms of this Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement will prevail. Nothing contained herein will be deemed to alter, modify, expand or diminish the terms of the Purchase Agreement.

This Assignment will be governed by and construed in accordance with the laws of the State of New York, without giving effect to any law or rule that would cause the laws of any jurisdiction other than the State of New York to be applied.

This Assignment may be executed in two or more counterparts, each of which will be deemed to be an original copy of this Assignment but all of which, when taken together, will constitute one and the same agreement.
