**DECLARATION FOR CORRECTION OF ASSIGNMENT IMPROPERLY FILED AND
RECORDED BY ANOTHER PERSON AGAINST OWNER'S TRADEMARK
UNDER MPEP 323.01(C)**

The above-identified Registrant and owner respectfully submits the following Declaration in this matter to correct an assignment improperly filed and recorded by another person against registrant's and owner's mark BULLDOG.

CLAIM OF TITLE SUMMARY

The chain of title should not be considered altered by the improperly filed and recorded assignment against the mark BULLDOG, Registration Number 2892221, on July 14, 2005 by another person not authorized by the true owner, Bulldog Office Products, Inc., details of which are discussed below. The original applicant (now registrant) and owner, Bulldog Office Products, Inc., has been and continues to be the owner of the mark BULLDOG, Registration Number 2892221, and there has not been, nor should be, any assignment recorded against same.

IMPROPERLY FILED AND RECORDED ASSIGNMENT DETAILS

On July 14, 2005, Glen M. Burdick of Dunlap, Coddling & Rogers, P.C. improperly filed and recorded with the U.S. Patent and Trademark Office an assignment executed on July 5, 2005 assigning the entire interest in a trademark from assignor FB Botanicals, Inc. to assignee Toma's L.L.C., Reel 3191, Frame 0848 – see Exhibit A. Mr. Burdick intended to record the assignment against Registration Number 2829221 (Mark: BRONZY BABE), which he subsequently did on November 15, 2005 – see Exhibit B. A typographically error of the Registration Number on the cover sheet submitted by Mr. Burdick on July 14, 2005 is the cause of the assignment being improperly filed and recorded against the mark BULLDOG, Registration Number 2892221 – see Exhibit A. However, Mr. Burdick did not follow USPTO procedure and file and record a corrective assignment for Registration Number 2829221 (Mark: BRONZY BABE) to correct the erroneous assignment cover sheet submitted on July 14, 2005 and to remove the improperly filed and recorded assignment record from the


U.S. Trademark Assignment Database with regards to Registration Number 2892221 (Mark: BULLDOG), owned by Bulldog Office Products, Inc.

CONCLUSION

Registrant and owner, Bulldog Office Products, Inc., respectfully requests that (1) the assignment recorded on reel 3191, frame 0848, as noted in Exhibit A be transferred from Registration Number 2892221 (Mark: BULLDOG) to Registration Number 2829221 (Mark: BRONZY BABE), and (2) this Declaration be recorded against Registration Number 2892221 (Mark: BULLDOG) and be assigned its own reel and frame numbers. 
