RELEASE OF TRADEMARK SECURITY INTEREST (the "Trademark Release") dated as of July 30, 2010, by VENTURE LENDING & LEASING III, INC. ("Venture"). Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement referred to below.

A. Reference is made to the Loan and Security Agreement dated as of July 17, 2000, between Venture and Coremetrics, Inc. (the "Company" or the "Trademark Owner"), as amended by an Amendment dated as of April 10, 2002 and a Second Amendment dated as of October 24, 2002 (as amended, supplemented or otherwise modified from time to time prior to the date hereof, the "Security Agreement").

B. Pursuant to the Security Agreement, the Trademark Owner granted a security interest to Venture, for its benefit, in, among other things, all right, title and interest of the Trademark Owner in certain trademarks and trademark applications set forth on Schedule I hereto (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office as of May 9, 2002 at Reel/Frame 2501/0939.

C. In connection with the termination of the Security Agreement, the Trademark Owner has informed Venture of its desire to obtain the release of all right, title and interest of Venture in and to the Trademarks under the Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Venture hereby absolutely, unconditionally and irrevocably releases all of its right, title and interest (including, without limitation, security interests) in and to the Trademarks. Venture hereby assigns, transfers and sets over to the Trademark Owner all right, title and interest that Venture may have in or to the Trademarks under the Security Agreement, together with the goodwill of the business symbolized by each such Trademark.

Venture agrees to perform all further acts and to execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Trademark Release. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademarks, Venture will execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.


This Trademark Release shall be governed by and construed in accordance with the law of the State of New York and shall be binding upon Venture's representatives, successors, assigns and transferees.
